RIFB WINS APEX AWARD

RI Farm Bureau has once again qualified for the prestigious Apex Award, presented by the American Farm Bureau Foundation (the educational arm of the American Farm Bureau). The award is given to any state that has donated at least 10% more to the Foundation than the previous year. Donations from individual members, Silent Auction purchases and donations from county and state Farm Bureaus all contribute to achieving the Apex Award.

RI Farm Bureau has won the award 4 out of the last 5 years.

GAP / FSMA TRAINING

The URI Cooperative Extension Food Safety Program will be offering a FSMA Produce Safety Rule/Produce Safety Alliance Approved Grower and RI GAP Training on Weds/Thurs, March 22-23 at Building 75, URI East Farm, Route 108, Kingston.

The training will allow farmers to become part of our RI GAP audit program. RI farmers will have the option to obtain the PSA/AFDO certificate that will prove you have taken the "approved" course per the rule. For those farmers who have already taken RI GAP training, that training does not count toward compliance.

If you are affected by the new FSMA rule you have to get the PSA/AFDO certificate. Those who gross more than \$500,000 per year must be in compliance by 2018. If you make less than 25K you are exempt. Those that fall inbetween may have until 2019 or 2020 to comply.

The cost of a PSA/AFDO certificate is \$35 for each person (check or cash). No more than 2 people per farm may attend.

The deadline to register is March 1. However there still may be room if you get this after March 1.

RIFEP provides Ag Producers and Ag-based Small Businesses with current information on energy, grant opportunities and supportive events.

Grants are available for Biomass, Geothermal, Hydropower, Hydrogen, Small and Large Wind Generation, Small and Large Solar Generation and Tidal.

Grants are also available for Insulation, Lighting, Cooling or Refrigeration Units, Switching from diesel to electric irrigation motors and replacement of energy-inefficient equipment.

NRCS ANNOUNCES SIGN UP FOR PROGRAMS

The Natural Resources Conservation Service (NRCS) encourages farmers and forest landowners to sign up for NRCS conservation funding. FY 2017 funding is available for private agricultural land and private forestry or woodland owners in RI under the Environmental Quality Incentives Program (EQUIP), Agricultural Management Assistance Program (AMA) and Regional Conservation Partnership Program (RCPP).

The financial and technical assistance is available to assist private land owners and managers in addressing farm, field, forest, wildlife, water, and/or plant management issues including: erosion control, irrigantion systems, fencing, forestry management, pasture and hayland planting, riparian buffers, wildlife habitat and many more.
